**ORDER FOR EXPUNGEMENT OF ARREST RECORD**

Pursuant to K.S.A. 2017 Supp. 21-2410

The Court, upon agreement of the parties, having received the evidence, and/or having heard statements of counsel having reviewed the file, finds as follows:

**IT IS THEREFORE ORDERED** that the defendant's arrest records herein, named above, shall be expunged and defendant shall be treated as not having been arrested. The Clerk of the District Court, upon receipt and filing herein, shall send a certified copy of the Order of Expungement to the Kansas Bureau of Investigation which shall notify the Federal Bureau of Investigation, the Secretary of Corrections, and any other criminal justice agency which may have a record of the arrest described herein:

*If the expungement is granted because of 5d of 5e above,*

**IT IS FURTHER ORDERED**, in the interest of public welfare, that the defendant shall disclose the arrest herein expunged as follows:

1. In any application for employment as a detective with a private detective agency as defined in K.S.A. 75-7b01 and amendments thereto; as security personnel with a private patrol operator as defined by K.S.A. 75-7b01 and amendments thereto; or with an institution, as defined in K.S.A. 76-12a01 and amendments thereto, of the Department of Aging and Disability Services.
2. In any application for admission, or for an order of reinstatement, to practice of law in this state.

3. To aid in determining the petitioner's qualifications for employment with the Kansas Lottery or for work in sensitive areas within the Kansas Lottery as deemed appropriate by the Executive Director of the Kansas Lottery.
4. To aid in determining the petitioner's qualifications for executive director of the Kansas Racing and Gaming Commission, for employment with the Commission or for work in sensitive areas in pari-mutuel racing as deemed appropriate by the Executive Director of the Commission, or to aid in determining qualifications for licensure or renewal of licensure by the Commission.
5. Upon application for a commercial driver's license under K.S.A. 8-2,125 through 8-2,142 and amendments thereto.
6. To aid in determining the petitioner's qualifications to be an employee of the state gaming agency.
7. To aid in determining the petitioner's qualifications to be an employee of a tribal gaming commission or to hold a license issued pursuant to a tribal-state gaming compact.
8. In the following circumstances as deemed appropriate by the Court:

Subject to the disclosures required above, in any application for employment, license, or other civil right or privilege, or any other appearance such as a witness, the Defendant may state that he/she has never been arrested.
