

RESOLUTION 25-2439

A RESOLUTION ESTABLISHING MEETING DATES/TIMES FOR THE BOARD OF COUNTY COMMISSIONERS FOR 2026

WHEREAS, the Board of County Commissioners of Saline County, Kansas, has via Charter Resolution exempted itself from the requirements of K.S.A. 19-209 and substituted the requirements of K.S.A. 19-206, and

WHEREAS, K.S.A. 19-206 provides, in part, that “the board of county commissioners shall meet in regular session, at the county seat on such days and at such times each month, as established by resolution adopted by the board”; and

WHEREAS, the Commission has given previous direction to the County Administrator to prepare a proposed schedule of meetings for 2026;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Saline County, Kansas, as follows:

1. It shall be the policy of the Commission to meet in regular session twice each month, with such meetings to generally occur on the first and third Tuesdays each month. It shall also be the policy of the Commission not to meet on primary or general election days that are known in advance of establishing the annual schedule of Commission meetings.
2. It shall be the policy of the Commission to meet for dedicated study sessions six times per year. It shall also be the policy of the Commission to meet for brief work planning sessions monthly.
3. To provide for the efficient operation of accounts payable between regular meetings, the County Administrator is hereby designated and authorized, pursuant to K.S.A. 12-105b (e), to approve in advance of the Commission’s next regular meeting the payment of any claims which provide for a discount for early payment or for the assessment of a penalty for late payment. Records of such payments shall be submitted to the Commission at the next regular meeting.
4. For 2026, the Commission specifically intends to meet in regular session at the following dates and times, subject to cancellation by the Board Chair as deemed necessary:

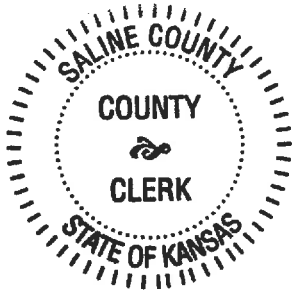
