#### **RESOLUTION NO. 20-2307**

A RESOLUTION REQUESTING THE SALINE COUNTY, KANSAS PUBLIC BUILDING COMMISSION TO ISSUE REVENUE BONDS FOR THE PURPOSE OF FINANCING ALL OR A PORTION OF THE COSTS OF ACQUIRING, CONSTRUCTING, REMODELING AND EQUIPPING IMPROVEMENTS TO CERTAIN PUBLIC BUIDLINGS TO BE LEASED TO SALINE COUNTY, KANSAS.

WHEREAS, the Board of County Commissioners (the "Board") of Saline County, Kansas (the "County") hereby deems it advisable to acquire, construct, and equip a radio communication network in the County (the "Network"); and

WHEREAS, the improvements necessary to acquire, construct and equip the Network include but are not limited to: (a) the acquisition of certain sites and construction of structural improvements thereon; (b) the acquisition of radios and other communication devices; and (c) the acquisition of certain technical services for the creation of the Network and continued operation thereof (collectively, the "Project"); and

WHEREAS, the estimated costs of the Project are approximately \$10,398,850, exclusive of financing costs; and

WHEREAS, the County anticipates entering into agreements with one or more units of local government, including the City of Salina, for participation in the Project and shared use of the Network; and

WHEREAS, under the authority of K.S.A. 12-1757 *et seq*. (the "Act"), the County has heretofore created the Saline County, Kansas Public Building Commission, a municipal corporation of the State of Kansas (the "PBC"); and

WHEREAS, upon the installation of its Members, the PBC has the power and authority under the Act to issue revenue bonds to provide funds for the purpose of paying all or a portion of the costs of financing the Project and the County deems it advisable to request that the PBC provide for the financing of the County's share of the costs the Project.

# BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SALINE COUNTY, KANSAS, AS FOLLOWS:

**SECTION 1. Authorization of the Project**. It is hereby deemed and declared to be necessary to authorize the Project.

SECTION 2. Financing of the Project. In order to pay a portion of the costs of the Project and related utility and infrastructure extension, reserves and financing costs, it is necessary and desirable for the PBC to issue revenue bonds in one or more series (the "Bonds"). It is hereby requested that the PBC, upon the installation of its Members, issue the Bonds in an aggregate amount not to exceed \$6,500,000, in accordance with the provisions of the Act and all other laws of the State of Kansas supplemental thereto or amendatory thereof. The County hereby requests that the PBC proceed with the issuance of such revenue bonds. The County also hereby declares an intent to enter into a lease or lease-purchase agreement with

the PBC pursuant to the Act to provide for the source of repayment of the debt service on the Bonds and other expenses, subject to final approval of such lease by the Board.

**SECTION 3. Reimbursement.** The County hereby declares an official intent to reimburse expenditures for Project costs incurred on or after 60 days prior to this date pursuant to Treasury Regulation §1.150-2.

SECTION 4. Effective Date. This resolution shall be effective from and after its adoption.
